## Important information on the application

#### 1. General information

Access to designated areas of the airport by vehicle or on foot requires the consent of Fraport AG. As proof of its consent, Fraport AG issues Airport ID Cards and Vehicle ID Cards. Every individual working at Frankfurt Airport and every vehicle operated at Frankfurt Airport requires an ID Card. As a rule, only one ID Card is issued to each individual and vehicle.

### 2. Applying for a Vehicle ID Card

Applications for Airport and Vehicle ID Cards must be submitted to the Airport ID Card Service Center (SCF) of Fraport AG in writing. The respective forms supplied by Fraport AG for this purpose (<a href="http://www.fraport.com/en/business-partner/services/airport-id-cards.html">http://www.fraport.com/en/business-partner/services/airport-id-cards.html</a>) must be used. To ensure that your application for an ID card is processed quickly and properly, all the information required on the form must be entered digitally. The application must be fully completed, signed and send in PDF format by e-mail (combined in one document, including appendices) to flughafenausweise@fraport.de. If you want to send a password-protected file, please contact the e-mail address above in advance. Each application will be reviewed individually and must state the reasons why an ID Card is being requested.

There is no legal entitlement to issuance of ID Cards or specific authorization. All ID Cards are the property of Fraport AG

Fraport AG conducts routine checks of the issued ID Cards.

When picking up their Vehicle ID Card, applicants must show the original vehicle registration certificate, TÜV report, UVV or operating permit to the staff of the Airport ID Card Service Center (SCF).

Applicants must prove they have an operational necessity to access the apron. That proof is given if the company has a contractual relationship with Fraport AG, and Airport ID Cards have already been issued to the company, and at least one person from the company submitting the application possesses an apron driver's license.

- if the application is for a personal vehicle, the individual whom the vehicle is registered is employed by the applicant and needs to use his or her personal vehicle for business trips to perform his or her work on the grounds of Frankfurt Airport.
- if the application is for a personal vehicle, the applicant will notify the Airport ID Card Service Center (SCF) immediately if the individual to whom the vehicle is registered leaves the service of the applicant, no longer uses the vehicle, or uses a different vehicle.
- it will use apron license plates issued by the Airport ID Card Service Center when entering the apron.
- the Vehicle ID Card and apron license plates will be returned on time and in the proper manner. If not, the company will pay the associated fee as listed in the fee schedule.
- the Vehicle ID Card will be stored in a safe place and visibly displayed in the vehicle while on the apron.
- it will report any suspected or actual loss to the Airport ID Card Service Center (SCF) or the Fraport AG Safety & Security Control Center (phone: 069 690-22222) immediately.
- ID Cards are the property of Fraport AG. As such, they must be returned to the owner immediately when they are no longer valid or other condition for possessing one are no longer met.

#### The company submitting the application confirms that:

- it will bear the cost of processing the application as well as issuing the Vehicle ID Card and any apron license plate that may be required.
- while using a vehicle in the operational area, it can provide documentation of current motor vehicle liability insurance coverage totaling at least EU 5 million for personal injury and property damage occurring at Frankfurt Airport.
- while using a vehicle on the apron, it can provide documentation of motor vehicle liability insurance coverage totaling at least EUR 50 million for personal injury (a minimum of EUR 8 million per injured person), property damage, and financial losses occurring at Frankfurt Airport.
- it will notify the Airport ID Card Service Center (SCF) of Fraport AG if the vehicle is sold or will no longer be used at Frankfurt Airport, or if it no longer meets the requirements for possessing a Vehicle ID Card.
- the issued Vehicle ID Card will not be used to give other vehicles access to the grounds.
- Only vehicles in a technically sound and safe operating condition may be oper-ated on the airport grounds. Both the owners and drivers of the vehicles are re-sponsible in this regard.
- Vehicles with an official registration, which require an official vehicle license plate, must undergo a valid technical inspection. The validity of the technical in-spection is indicated by the technical inspection sticker on the rear vehicle li-cense plate.
- Vehicles without an official registration require a valid inspection under accident prevention regulations (accident prevention inspection).

  This must be indicated in the form of an accident prevention inspection sticker, which should be affixed next to, on or at least close to the

Fraport AG records, stores and uses the vehicle registration number you have provided above, the operating areas permitted for the vehicle, the validity period of the access authorization and the ID card number assigned to the vehicle for the entire validity period of the vehicle ID card for the purpose of documenting and checking the access authorization in front of the access gates to the operating area at the airport. In order to check the existing access authorisation, a video camera at the service gates records the registration number of the vehicle parked in front of the barrier and transmits the registration number for comparison to the database created for this purpose with all access-authorised registration numbers. If the vehicle is authorised to enter the company area at this company gate, the barrier opens automatically after the comparison and you can enter. Afterwards, the registered number plate is immediately deleted.

The licence plate recognition by means of a video camera is carried out in accordance with Art. 6 Para. 1 f) of the German Data Protection Act (DSGVO) to check access authorisation to the respective part of the operating area and has the aim of enabling authorised vehicles to enter the operating areas (East operating area, Cargo City South, roads close to the terminal) of Frankfurt Airport more conveniently and quickly, to avoid traffic jams and to ensure that unauthorised vehicles do not enter the operating area.
