Important information regarding the application

1. General information

Any access to the Airport's designated areas requires the consent of Fraport AG, given by the issuance of Airport and Vehicle ID Cards. An ID Card is required for every person working at Frankfurt Airport, as well as every vehicle operated at the Airport. As a rule, only one ID Card is issued to each individual and vehicle. The responsibility for timely applications or renewals rests with the applicant. There will be costs that will arise für the processing of the airport ID cards, according to the specifications (you can find this under www.fraport.com/flughafenausweise).

2. Applying for an Airport ID Card

Applications for Airport and Vehicle ID Cards must be submitted in writing to Fraport AG's Airport ID Card Service Center (SCF). Whenever possible, the standard forms provided by Fraport AG must be used (https://www.fraport.com/en/business-areas/services/airport-id-cards.html). All required informations in the application must be fully completed and digitally filled out and is to be signed and sent together as one document, with a max. file size of 2 MB via email as a PDF file to flughafenausweise@fraport.de.

If you wish to send a password protected file, please contact the e-mail address above in advance.

Each application will be reviewed individually, and must state the reasons why an ID Card is being requested.

There is no legal entitlement to the provision of ID cards or for specific access and entry authorizations.

If the occupation is taking place in the safety area of Fraport AG, then an application for the introduction of a reliability check has to be submitted seperately or the recognition of an existing reliability check from a different federal state has to be attached.

3. Training

For an Airport ID card including access to the security area, following trainings are required:

Yellow: The German Aviation Security Training + Basic safety training Blue: The German Aviation Security Training

The German Aviation Security Training must be at least according to chapter 11.2.6 of the (EU) Regulations No. 2015/1998.

This can be completed through Fraport AG followed by an exam at the end (web-based). You will receive the login details after your application has been submitted or via E-Mail. The duration of the training is approximately 3 hours.

The German Aviation Security Training from a different provider or trainings that go beyond 11.2.6, must be punctually sent für recognition to flughafenausweise@fraport.de.

The basic safety training (SMS) can only be completed trough Fraport AG. This training is web-based following an exam at the end. You will receive the login details together with the German Aviation Security Training. The duration of the training is approximately 1 hour. For any questions regarding the SMS training please contact safety-schulung@fraport.de.

For both trainings as well as the recognition, costs are incurred in accordance with Fraport AG's service specifications.

- I will store the Airport ID Card in a safe place, and will report any suspected or actual loss immediately to the Fraport AG's Safety & Security Control Center (Tel: 069 690-22222).
- Technologically secured access points opened using my ID Card will only be traversed by me alone.
- ID Cards are the property of Fraport AG. As such, they must be returned to the owner immediately when they are no longer valid or other (e.g. lack of training or background checks) conditions for possessing one are no longer met.
- I understand and acknowledge both the Airport User and the ID Card Regulations.

Under Section 18, in conjunction with Section 10 of the German Aviation Security Act (LuftSiG), the ID card holder will be committing an offence if:

- Deliberately or negligently failing to wear the Airport ID Card visibly when in restricted areas.
- Lending or allowing a third party to use the ID Card.
- he doesn't return his airport ID card, or doesn't return it on time to the Servicecenter Airport ID card
- Failing to report the loss of the ID Card in a timely manner, or not reporting the loss at all.
- Using the card to gain unauthorized access to restricted areas for oneself or a third party.

To enable prosecution of such offenses, the necessary information may be shared with the competent authorities. Such offenses are punishable with a fine of up to 10,000 Euros.

In case of acceptance of the background check, I agree that

- For the purpose of the background check my personal data will be forwarded to the responsible aviation security authority, Police Headquarters Frankfurt am Main, processed and stored. In addition, a data alignment is performed for this purpose on the basis of the copy of my EU ID card or passport that was made available by me (According to section 2.2 of Fraport AG's ID Card Regulations, a copy of the valid EU identity card or passport must be attached to the application in Latin script. The residence permit alone is not enough. Alternatively, you have the option of presenting the identity document upon submission of the application. Data protection notice: access and serial number of the identity card may be blackened).
 - In the event of an inconsistency between the data provided on the airport ID card application and the data specified on the copy of the valid EU ID card or passport accompanying my application, the data specified on the valid EU ID card or passport shall prevail and may be forwarded to theresponsible aviation security authority. The copy of the valid EU ID card or passport will be destroyed within Fraport AG's area of responsibility at the latest after the notification about the results of the background check.
- For the purpose of recertification, my information can be submitted to the relevant aviation authority and stored electronically without additional consent.
- The agencies and authorities involved in accordance with Section 7, Paragraph 2, Sentence 3, of the LuftSiG will share any findings relevant to security with the competent aviation authority.
- The Aviation Authority will obtain information from law enforcement agencies if there are any concerns regarding my trustworthiness.
